WHEREAS, Larry Kennedy received his bachelor's degree in economics at University of California, Santa Barbara; his Master of Business Administration degree from California Lutheran University; and is a current Camarillo resident; and

WHEREAS, Larry Kennedy, a Vietnam Southeast Asia United States Navy Disabled Veteran, has worked tirelessly to advance the success of students through access, particularly first-generation college students and veterans, with his leadership on the California Community College Trustees Board, and as Co-Founder of the League of California Veterans Caucus; and

WHEREAS, Larry Kennedy has provided outstanding leadership and guidance to the District and colleges as Board Chair, Vice Chair, and Board Committee Chair and Member, with dedication and commitment; and

WHEREAS, Larry Kennedy, in service to the community, has held leadership roles with the American Red Cross; County of Ventura Economic Development Collaborative, Ventura County Workforce Investment Board; Rotary International; County of Ventura Management Council; Oxnard College Academic Senate; Employer Advisory Council; Chamber of Commerce; Ventura County Regional Energy Alliance; California Workforce Association; Oxnard College Foundation; and




