NOW, THEREFORE, BE IT RESOLVED, that for the ensuring year (effective July 1, 2023), the classified positions set forth above shall be discontinued to the extent set forth above.

BE IT FURTHER RESOLVED, that no later than March 15, 2023, the Governing Board and all affected permanent classified employees shall be given written notice by the Chancellor or the Chancellor's designee that it has been recommended that notice by given to the employee, stating the reasons that the employee's services will not be required for the ensuring year, and informing the employee of the employee's displacement rights, if any, and reemployment rights.

BE IT FURTHER RESOLVED, that nothing herein shall be deemed to confer any status or rights upon probationary classified employees, short-term employees, as defined in section 88013, or other employees in addition to those specifically granted to such employees by statute.

BE IT FURTHER RESOLVED, that the Chancellor or the Chancellor's designee is authorized and directed to take any other actions necessary to effectuate the intent of this resolution.
